論壇介紹

About the Forum

習近平主席在 2024 年 12 月視察澳門時強調，要用好澳門中西薈萃的文化優勢，促進國際人文交流，打造中西文明交流互鑒的重要窗口。澳門的法律制度具有典型的歐陸法特徵，舉辦本次論壇將有助於發揮澳門的上述優勢，增進中國與歐陸法國家在法治領域的交流互鑒，探討歐陸法在各國的實踐特色，並展現澳門特色「一國兩制」法治建設成就。

During his stay in Macao in December 2024, President Xij Jinping underscored that as a place where Chinese and Western cultures merge, Macao should promote international people-to-people exchanges, and turn the city into an important window of exchanges between Chinese and Western civilizations. Macao's legal system has the classic features of continental law. Hosting this forum will help leverage Macao's above-mentioned strengths, enhance exchanges and mutual learning between China and continental law countries in the rule of law field, exploring practical characteristics of continental law as applied across various jurisdictions and showcasing Macao's achievements on rule-of-law construction under "one country, two systems".

徐顯明，教授，法學博士，榮譽博士，博士生導師。最高人民檢察院諮詢委員會副主任，中國法理學研究會名譽會長，教育部法學學科教學指導委員會主任委員，教育部、中央政法委卓越法治人才培養計劃指導委員會主任委員等。歷任第十屆全國人大法律委員會委員，十一屆、十二屆、十三屆全國人大常委，十一屆全國人大法律委員會委員、十二屆全國人大法律委員會副主任委員、十三屆全國人大監察和司法委員會副主任委員，中國政法大學校長，山東大學校長，最高人民檢察院副檢察長，中國法學會副會長。



Xu Xianming, Professor of Law, Doctor of Laws, Honorary Doctorate, and Doctoral Supervisor. He is the Vice-Chairman of the Advisory Committee of the Supreme People's Procuratorate, Honorary President of the China Jurisprudence Research Society, Chairman of the Teaching Steering Committee for Legal Studies under the Ministry of Education, and Chairman of the Steering Committee for the Outstanding Legal Talent Training Program jointly established by the Ministry of Education and the Politics and Law Commission of the CPC Central Committee. He has previously served as Member of the Law Committee of the 10th and 11th National People's Congress (NPC), Member of the Standing Committee of the 11th, 12th and 13th NPC, Vice Chairman of the Law Committee of the 12th NPC, and Vice Chairman of the Supervisory and Judicial Affairs Committee of the 13th NPC. He also served as President of China University of Political Science and Law, President of Shandong University, Deputy Procurator-General of the Supreme People's Procuratorate, and Vice-President of the China Law Society.

愛德華多·維拉·克魯斯·平托，博士，里斯本大學法學院院長、正教授。擔任葡萄牙司法高級委員會委員及治安法官監督委員會委員，還在里斯本大學理學院、巴西聖保羅天主教大學法學院、塞阿拉聯邦大學法學院及意大利薩薩里大學法學院擔任客座教授，並擔任多家學術期刊編委，包括《里斯本大學法學院學報》等。研究領域涵蓋羅馬法、網絡安全法、法律史、民法和司法法。



Dr. Eduardo Vera-Cruz Pinto is the Dean of the Faculty of Law, University of Lisbon and a Full Professor. He serves as a member of the Superior Council of the Judiciary and of the Monitoring Commission for Justices of the Peace in Portugal. He holds visiting professorships at the Faculty of Sciences of the University of Lisbon, the Pontifical Catholic University of São Paulo, the Federal University of Ceará, and the University of Sassari (Italy). He is a member of the editorial boards of several academic journals, including the Revista da Faculdade de Direito da Universidade de Lisboa and others. His research areas cover Roman law, cybersecurity law, legal history, civil law, and judicial law.

伊萬·卡蒂洛，博士，中國法研究所創始人兼主席，歐中經濟合作與發展理事會秘書長，意中經濟商務發展協會主席。還擔任歐盟委員會歐中研究與創新對話的科學專家，路易斯大學國際與戰略研究中心（CISS）中國問題專家，中國政法大學兼職教授，以及威海仲裁委員會仲裁員。曾任中南財經政法大學助理教授、特倫托大學客座教授，為歐洲、中國和美國政府及企業提供諮詢，並發表大量關於中國法律文化、民法典編纂及人工智能監管的著述。



Ivan Cardillo is Founder and Chairman of the Institute of Chinese Law, Secretary-General of the Europe-China Economic Cooperation and Development Council, and Chairman of the Italy-China Economic and Business Development Association. He also serves as Scientific Expert for the European Commission's EU-China Research and Innovation Dialogue, China Expert for the Center for International and Strategic Studies (CISS) at Luiss, Adjunct Professor at China University of Political Science and Law, and Arbitrator at the Weihai Arbitration Commission. A former Assistant Professor at Zhongnan University of Economics and Law and Visiting Professor at the University of Trento, he has advised governments and firms across Europe, China, and the U.S., and has published extensively on Chinese legal culture, civil codification, and AI regulation.

畢經緯 Bi Jingwei

畢經緯，博士，現任澳門科技大學法學院副教授、澳門法律與金融研究中心主任，澳門金融法律學會理事長。兼任中國法學會香港基本法澳門基本法研究會理事，全國外國法制史研究會理事，中國社會科學院法學研究所珠海經濟特區法治協同創新中心研究員。曾赴德國明斯特大學、帕紹大學、波恩大學、圖賓根大學，意大利羅馬大學以及新加坡國立大學客座訪學。主要研究領域包括合同法、信託法、侵權法與羅馬法。



Bi Jingwei is currently an Associate Professor at the Faculty of Law of the University of Science and Technology of Macau, Director of the Macau Centre for Law and Finance, and President of the Macau Financial Law Association. He also serves as a Council Member of the Hong Kong Basic Law and Macau Basic Law Research Association of China Law Society, a Council Member of the National Foreign Legal System Institute, and a Research Fellow at the Zhuhai Collaborative Innovation Centre for the Rule of Law, the Institute of Law of the Chinese Academy of Social Sciences. He holds visiting Fellowships or Professorships at the University of Münster, the University of Passau, the University of Bonn and the University of Tübingen in Germany; the Sapienza University of Rome, the Tor Vergata University of Rome in Italy; and the National University of Singapore. His main areas of research include Contract law, Trust law, Tort law and Roman law.

克里斯蒂安·梅斯特 Christian Mestre

克里斯蒂安·梅斯特，博士，斯特拉斯堡大學公法教授及歐洲學院歐盟法教授，曾任斯特拉斯堡大學校長（1998-2003 年），現任該校榮譽校長及法學院榮譽院長。他還擔任歐洲國際研究中心主席，並任歐洲委員會法律顧問。研究領域涵蓋歐洲一體化、制度法及農業與凝聚政策。



Christian Mestre is Professor of Public Law at the University of Strasbourg and Professor of European Law at the College of Europe. He served as Rector of the University of Strasbourg (1998–2003) and now holds the titles of Honorary President and Honorary Dean of its Faculty of Law. He chairs the Centre for International and European Studies and acts as a legal advisor to the Council of Europe. His research focuses on European integration, institutional law, and agricultural and cohesion policies.

簡能思 Vitalino Canas

簡能思，博士，里斯本大學法學院助理教授、律師。曾任葡萄牙國務秘書、議會議員（1999 – 2019 年）及北約議會大會副主席（2017 – 2019 年），並為世界銀行等國際機構提供諮詢。曾在澳門大學和莫桑比克蒙德拉內大學任教。研究領域為憲法、政治學和行政法。獲里斯本大學政治法律科學博士學位，著有大量關於憲法正義與比例原則的成果。



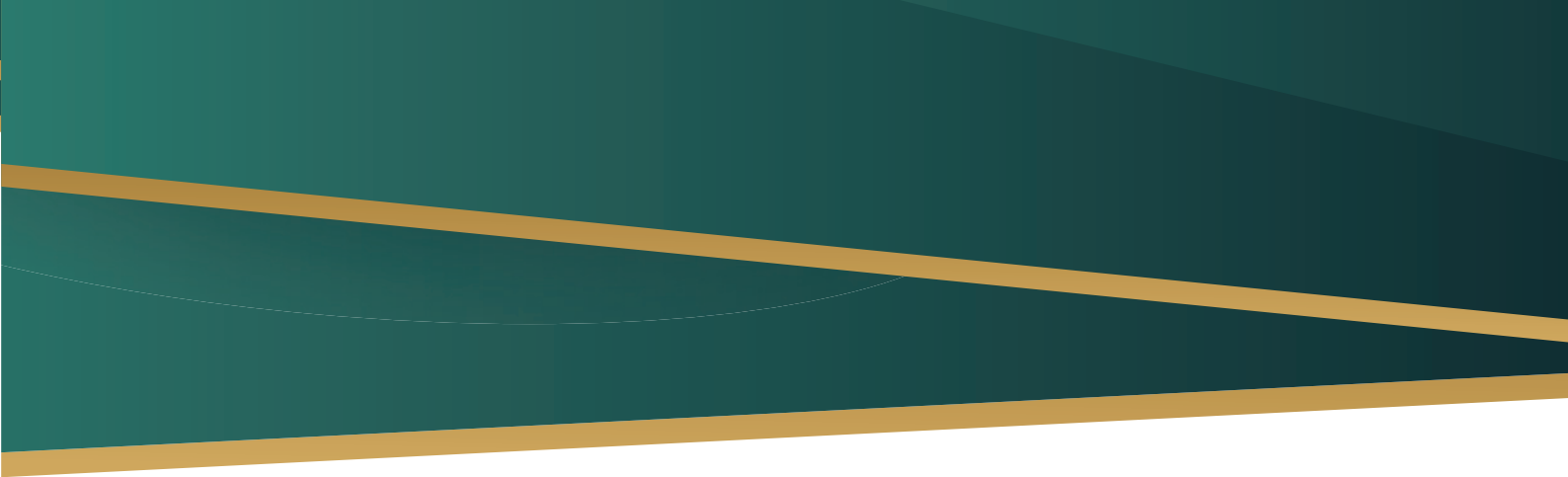
Vitalino Canas is an Assistant Professor of the Faculty of Law, University of Lisbon and a lawyer. He served as Secretary of State, Member of Parliament (1999–2019), and Vice-President of the NATO Parliamentary Assembly (2017–2019), and has consulted for the World Bank and other international bodies. He has taught at the University of Macau and Eduardo Mondlane University. His research covers constitutional law, political science, and administrative law. He holds a PhD in Political and Legal Sciences from the University of Lisbon and has published extensively on constitutional justice and proportionality.

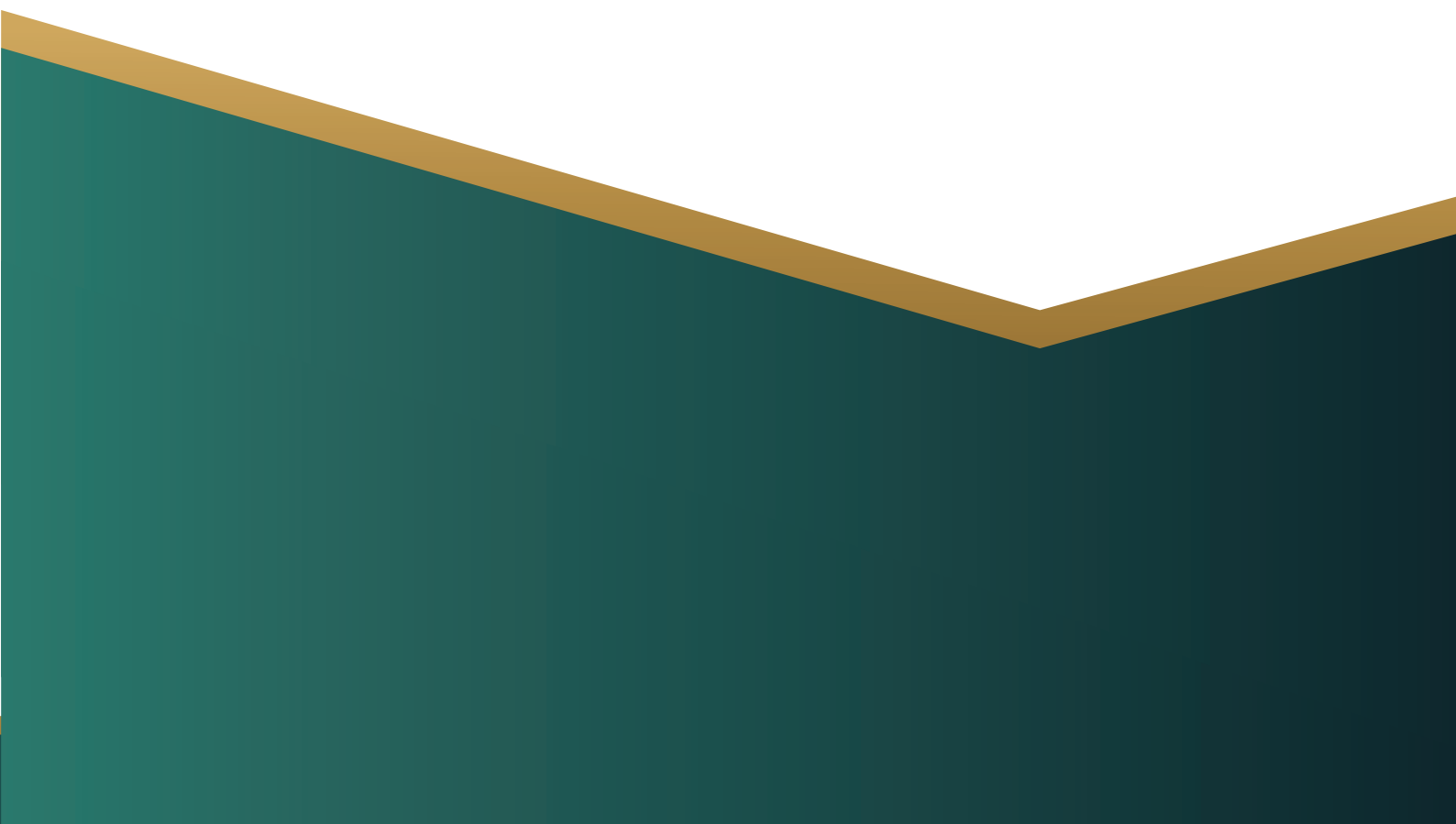
Luís Canjongo Januário is Head of the Department of Legal Studies and Research at the Faculty of Social Service of the University of Luanda, Angola. His research covers Public International Law, Diplomatic and Consular Law. He is the author of International Cultural Heritage Law: The Case of Ahmad Al Faqi Al Mahdi. He served as a researcher at the Center for International Law Studies at the State University of Rio de Janeiro. He worked in the legal sector of the Consulate General of Angola in Rio de Janeiro, providing consular legal assistance and judicial matters involving Angolan nationals in Brazil.

埃里克·希爾根多夫 Eric Hilgendorf

埃里克·希爾根多夫，德國維爾茨堡大學法學教授，刑法、刑事訴訟法、法理學、資訊法與法律資訊學教研室主任。在刑法學與法理學領域著述頗豐，主編了著名的《刑法手冊（九卷）》。其代表作已被翻譯成中文、英文、西班牙文、日文和韓文等多種語言。目前受聘為北京大學法學院全球教席教授和中國人民大學法學院客座教授。



Eric Hilgendorf is professor of law at the Julius-Maximilians-Universität Würzburg and chairman of the Department of Criminal Law, Criminal Justice, Legal Theory, Information and Computer Science Law. He is author of numerous books on Criminal law and Legal theory, and editor of the renowned “Handbook of Criminal law” (9 vols). His influential works have been translated into many languages, among them Chinese, English, Spanish, Japanese and Korean. He holds honorary professorships of Law School of Peking University and Renmin University of China.

法比奧·科斯塔·莫羅西尼 Fabio Costa Morosini

法比奧·科斯塔·莫羅西尼，博士，巴西南里奧格蘭德聯邦大學國際法教授。研究領域為國際經濟法以及全球南方視角下的國際法。曾擔任密西根大學法學院、紐約大學法學院、歐洲大學研究院的訪問學者和世界貿易組織研究員。系《從全球南方視角重新構建國際投資法》（劍橋大學出版社）的合編者、《國際經濟法雜誌》（牛津大學出版社）的主編之一，並著有多部國際經濟法著作。



Fabio Costa Morosini is Professor of Law at the Federal University of Rio Grande do Sul (UFRGS), Brazil. His research focuses on international economic law, and Global South approaches to international law. He has held visiting appointments and fellowships at the University of Michigan Law School, New York University School of Law, the European University Institute, and the World Trade Organization. Professor Morosini is the co-editor of *Reconceptualizing International Investment Law from the Global South* (Cambridge University Press) and the author of numerous publications on international economic law. He serves as one of the Editors-in-Chief of the *Journal of International Economic Law* (Oxford University Press).

曼努埃爾·吉列爾梅·儒尼奧爾 Manuel Guilherme Júnior

曼努埃爾·吉列爾梅·儒尼奧爾，教授，莫桑比克蒙德拉內大學校長，並擔任葡萄牙語國家遠程教育協會主席。他擁有蒙德拉內大學和里斯本大學的法學博士學位，學術履歷豐富，曾擔任贊比西大學和天主教大學的領導職務。他曾是莫桑比克最高司法委員會的成員，也擔任過蒙德拉內大學合作辦公室主任。在學術之外，他曾是著名電視評論員、聯合國國際顧問，並出版過商法和憲法領域的著作。2026 年，他被浙江師範大學授予榮譽教授。



Manuel Guilherme Júnior is Rector of Eduardo Mondlane University (UEM) and President of the Portuguese-Speaking Countries' Distance Learning Association. He holds a PhD in Law from UEM and the University of Lisbon, with an extensive academic career including leadership roles at Zambeze University and the Catholic University. A former member of Mozambique's Superior Council of the Judiciary, he also directed UEM's Cooperation Office. Beyond academia, he was a prominent TV commentator, international consultant (UN), and published author in Commercial and Constitutional Law. In 2026, he was distinguished as an Honorary Professor at Zhejiang Normal University in China.

魏丹 Wei Dan

魏丹，北京大學法學士、葡萄牙科英布拉大學法學碩士、博士，中國首位葡語法學博士。澳門大學法學院副院長、教授、博士生導師。現任國際比較法科學院副主席、院士，國際法協會國際消費者保護委員會總報告人，歐美同學會第九屆理事。任多家仲裁機構仲裁員，是中國與巴西及葡語國家法律交流專家。



Wei Dan holds an LL.B. from Peking University and an LL.M. and Ph.D. in Law from the University of Coimbra, Portugal. She is China's first Ph.D. in Law trained in Portuguese. She serves as Associate Dean, Full Professor, and Ph.D. Supervisor at the Faculty of Law, University of Macau. She is Vice President and Titular Member of the International Academy of Comparative Law, Rapporteur of the International Law Association's Committee on International Protection of Consumers, and a member of the Ninth Council of the Western Returned Scholars Association. She also serves as an arbitrator for several arbitration institutions and is a leading expert on legal cooperation between China, Brazil, and other Portuguese-speaking countries.

王藝琳 Wang Yilin

王藝琳，澳門大學法學院助理教授。同時，她是墨爾本大學法學院高級研究員和《澳門環球法研究》副主編。她於日內瓦國際與發展高等研究院完成國際法博士學位，並獲得瑞士國家科學基金資助博士後研究和香港大學全球學者資助。她發表的論文可見於《國際爭端解決雜誌》、《中國國際法雜誌》、《亞洲國際法雜誌》、《法律和歷史評論》等。她的研究興趣主要是國際法的歷史與理論。



Wang Yilin is assistant professor at the faculty of law in the University of Macau. Meanwhile, she is a senior fellow at the law school of University of Melbourne and associate editor of Macau Journal of Global Legal Studies. 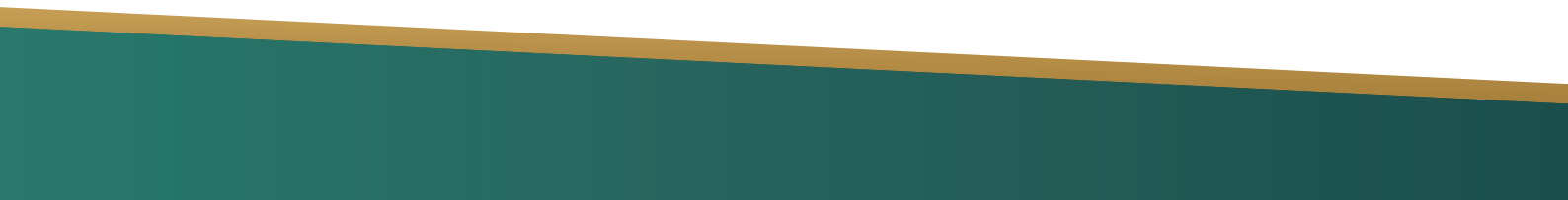

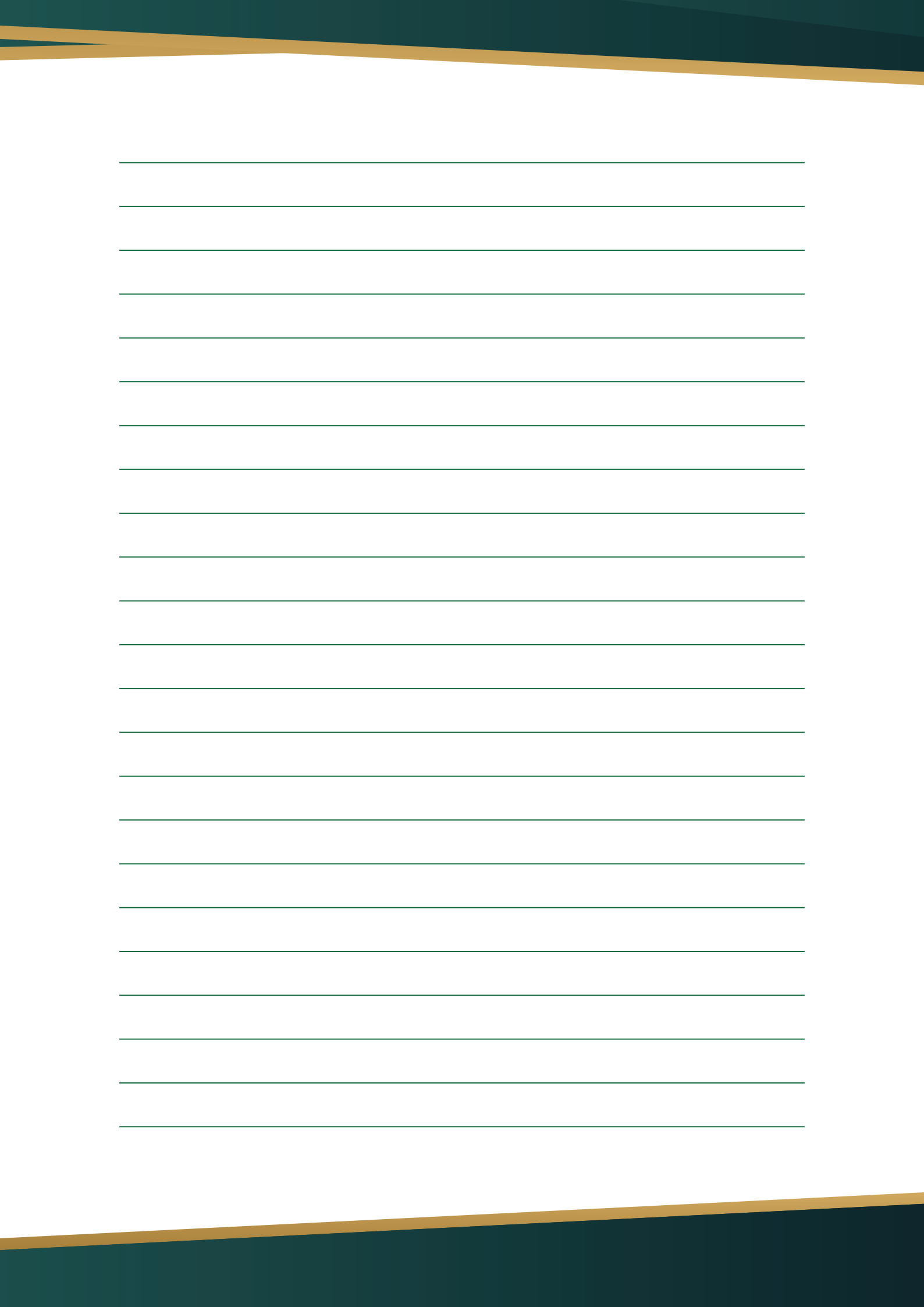
